Implementation, maintenance and improvement of the quality management system through:

- 6. GMP compliance, the guarantee that the products are manufactured and controlled according to the corresponding quality standards. Concern for both ,production and quality control, risk management and minimization, to ensure product quality, safety and effectiveness.

According to GMP:

- a) all manufacturing processes are clearly defined and systematically reviewed for the associated risks.
- b) qualification and validation are performed.
- c) all necessary resources are provided, including: sufficiently, adequately trained and qualified personnel, adequate spaces, appropriate equipment and services, appropriate materials and labels, approved procedures and instructions, adequate storage and transportation.
- d) the instructions and procedures are written in a clear and unambiguous language and applied specifically to the facilities offered.
- e) the procedures are correctly applied and entire personell is trained to do this.
- f) the records are performed during manufacture to show that all the measures required by the defined procedures and instructions have actually been taken and that the quantity and quality of the product are as expected. Any significant deviations are fully recorded and investigated with the objective of determining the root cause and the appropriate corrective and preventive actions are implemented .
- g) evidences that covers the production, which allows the complete traceability, are kept in an easily understandable and accessible form.

Implementation, maintenance and improvement of the *environmental management* system through:

- 1. Continuous improvement of technologies that can generate relevant environmental aspects.
- 2. Control of environmental factors (water, air emissions) on the organization's site.
- **3.** Correct and economical management of natural resources through continuous improvement of production processes with high performance and environmentally friendly equipment.
- **4.** Reduction of waste resulting from the production processes through the use of reusable packaging and through recovery .
- **5.** Energy consumption reduction through the use of advanced and efficient technologies.

Comunication:

This policy is communicated to the entire staff of the organization and analyzed annually to continuously adapt to its activities, legal requirements, regulations and other requirements to which the organization has subscribed.

At the same time, we ensure transparency in the organization's relations with the local community, neighbors, customers and suppliers.
